Ouyang,

Please see the statement below.

Start of the statement:

I am making this statement to tell the truth to our knowledge, instead of in support of or against anyone.

1. I got to know Ms. Ouyang during the 2014 Ohio Chinese Festival (<http://www.ohioccl.org/2014chinaday/>). I was a volunteer for the Festival. One of the Festival organizers asked me to give a drive for someone to the festival on Feb 1, 2014. Then Ms. Ouyang, who asked for the drive, called me gave me her address and time for the pick up. When I went to pick up Ms. Ouyang, I found that a senior couple also needed the drive to the Festival. From our conversation on the way, I learned that the senior couple was Dr. [REDACTED]'s parents, and Ms. Ouyang and Dr. [REDACTED] engaged but had not yet decided the specific date for their marriage. Dr. [REDACTED] needed to work during the weekend, but Ms. Ouyang wanted to take Dr. [REDACTED]'s parents to this festival. Since Dr. [REDACTED] could not leave his work early to pick them up in the afternoon, I offered them a ride back home after I received a call from Ms. Ouyang, who explained the situation to me.

2. One week later after my round way ride for Dr. [REDACTED]'s parents and Ms. Ouyang, they came to visit my house. Dr. [REDACTED] came to my house about two hours later after his work in a hospital. We chatted for a while, and then all my family (my wife, my mother-in-law, and I) went to Dr. [REDACTED]'s house to have a dinner under Dr. [REDACTED]'s invitation. We saw an engagement ring on Ms. Ouyang's left hand ring finger at that time.

3. In Dr. [REDACTED]'s house, we had a dinner together and watched a Chinese movie. When Ms. Ouyang was doing the washing and cleaning work after our dinner, Dr. [REDACTED]'s parents praised Ms. Ouyang as a model daughter-in-law in their eyes. Before we left Dr. [REDACTED]'s house, Dr. [REDACTED]'s mother asked Ms. Ouyang to turn on the computer in the study room and to show us their pictures taken during their Christmas vacation. His parents mentioned that they liked Ms. Ouyang, enjoyed the vacation time.

4. Since our dinner, my wife and I have not yet seen Ms. Ouyang or Dr. [REDACTED] again. My wife

and I do not know Dr. [REDACTED] and Ms. Ouyang broke their engagement until recently.
